Soldier Welfare & Morale / Care Packages & Related - Activities include sending care packages containing foodstuffs, personal grooming items, and recreational and exercise gear to U.S. Military Units serving abroad, mostly in combat zones. In 2012, over 2,000 care packages were mailed to over 150 separate military units. These activities were conducted in a warehouse space donated by a local business, however, the value of the donated warehouse space is not included in the dollar amount shown per IRS regulations. Approximately 10,000+ troops benefit from these activities.

4b (Code:) (Expenses \$ 82,208 including grants of \$ 0) (Revenue \$ 0)

Soldier Welfare & Morale / Troop Morale - During 2012, the organization conducted military appreciation events at two U.S. military installations with celebrities (NFL cheerleaders & musicians). Events included meet and greet visits, entertainment shows, photo and autograph sessions and video game contests. The organization also held a deployment event for an aircraft carrier and participated with other sponsors for a holiday party for wounded warriors and their families at a military hospital. Approximately 10,000+ military personnel benefited from these activities.

Soldier Welfare & Morale / Other - In 2012 the organization provided support to the family readiness group of a deployed unit and made a few de minimis contributions to other recognized charities that supported severely wounded soldiers.
